

# **Funding Application**

The Blue Mountain Village Foundation (BMVF) is dedicated to awarding grants to charitable organizations in the South Georgian Bay Region whose activities address social gaps in our community. BMVF is committed to enhancing quality of life including the areas of health, education, the arts, the environment, recreation and more.

Support is given in the form of cash grants to provide funding for specific projects that meet the Foundation's mandate and criteria. Operational costs or salaries will not be considered. Once the application review is complete, the Selection Committee will make recommendations to the Foundation's Board of Directors for final approval.

Application Deadline: February 11, 2022 (for Winter funding)

Updated criterial and guidelines for submissions have been developed for 2022 in order to reflect the most pressing needs identified in our community and by local social service agencies. The guidelines include the following:

#### **Basic Criteria:**

- Programs must address identified social gaps, service the South Georgian Bay Community, programs should be delivered between March 2022 & February 2023, and financial requests not to exceed \$5000.
- Social gaps include:
  - o Physical and emotional isolation due to COVID-19;
  - o Gaps in services and supports for seniors;
  - o Limited access to attainable housing;
  - o Food insecurity;
  - o Rise in mental health challenges, particularly anxiety;
  - o Reduction in access to all forms of health care services;
  - Labour shortages across all sectors as well as job losses in employment contexts; and impacted by COVID-19 Pandemic (e.g., performance artists, restaurant workers, etc.)
  - o Increase in family problems such as domestic abuse.
- All Basic Criteria outlined above must be met for grant applications to be reviewed by the selection committee.

#### **Enhanced Criteria:**

- Programs should address multiple community needs, or can be applicable to multiple social gaps.
- Programs and initiatives should support diversity (e.g., actively support youth, seniors, BIPOC, etc.).
- Programs should demonstrate community or organizational collaboration.
- Programs should demonstrate solid community communications plans.

### **Additional Requirements:**

In order to be eligible to receive a grant from the Blue Mountain Village Foundation the Applicant must:

- Commit to the preparation of a follow-up report.
- Be prepared to provide volunteers to support BMVF fundraising initiatives during the calendar year.
